

## Licence to use the EMBREA tools

THIS LICENCE is created on the date that the tool/s provided for you to use on this website are first used by you, or the date that you download a tool (whichever applies).

In this Licence the term “Tool” and “Tools” means the tool/s provided on this website, which include downloadable spreadsheet tools, which you decide to use and/or download. “We” and “our” in this Licence refers to HR Wallingford Ltd.

You and we agree as follows:

1. We licence the Tools for you to use and download free of charge for the period during which we make them available on our website on this basis. 5. We may at any time during the course of this Licence modify a Tool or upload a new version of a Tool. It is drawn to your attention that this may change some of the functionality of the Tool and may change the results of the Tool from the results that you have previously obtained.
